TalksOnLaw Partners with NY Chief Judge DiFiore's Emergency Legal Task Force and the Association of Pro Bono Counsel to Create a Video Resource for Disaster Victims: "DISASTER RELIEF - TOP 5 FEMA MISTAKES TO AVOID"

(New York) – Wednesday, August 22, 2018 – Today, the legal education platform <u>TalksOnLaw</u> announced the release of "Disaster Relief – Top 5 FEMA Mistakes to Avoid," its latest legal explainer focused on helping victims of natural disasters.

After a natural disaster, the process for obtaining FEMA disaster assistance is not automatic and victims seeking aid frequently make avoidable mistakes that delay or prevent their recovery relief. "Disaster Relief – Top 5 FEMA Mistakes to Avoid" breaks down these mistakes. The video, narrated by actress Adrienne Houghton, aims to help natural disaster victims in the U.S. protect their chances of receiving FEMA disaster assistance.

The 5-min video gives practical tips to help disaster victims of major storms, floods, or fires such as the Carr Fire still burning in California.

Judge DiFiore's Emergency Legal Task Force, established in 2017 by the Honorable Janet DiFiore, Chief Judge of the New York Court of Appeals, is charged with mobilizing pro bono legal assistance on behalf of disaster victims in an effort to support their recovery.
